

# **SAFETY NOTICE Department of Public Safety**

**Incident Type** Sexual Assault (Campus)

**Date** August 21, 2015

**Location\*** Residence Hall

**Description:** ETSU Public Safety received a report of a sexual assault that occurred on

August 20, 2015 in an on campus residence hall. A female student reported that a male student acquaintance sexually assaulted her. ETSU Public Safety is investigating the matter and no charges have been filed at

this time.

## **SAFETY TIPS and RESOURCES:**

\*A U.S. Department of Justice report cited studies indicating that the majority of campus sexual assaults are by an acquaintance (Krebs, et al., 2007).

\*Be an active bystander. When you observe conflict or unacceptable behavior, take steps to make a difference: assess the situation, evaluate options, and select a strategy for response. That could include reporting suspicious persons or behavior to Public Safety or the local police. Learn about <a href="Buccaneer Bystander Intervention">Buccaneer Bystander Intervention</a> options.

#### **CONSENT DEFINITION:**

An informed decision, freely given, made through mutually understandable words or actions that indicate a willingness to participate in mutually agreed upon sexual activity. Consent cannot be given by an individual who is asleep; unconscious; or mentally or physically incapacitated, either through the effect of drugs or alcohol or for any other reason; or, is under duress, threat, coercion, or force.
