



<b>Incident Type</b>	Aggravated Assault (Non Campus)
<b>Date</b>	September 18, 2015
<b>Location*</b>	Off Campus Fraternity House
<b>Description:</b>	On September 18, 2015, ETSU Public Safety received a Johnson City Police Department (JCPD) report of an incident at an off campus fraternity house. The incident involved an assault followed by shots being fired from a vehicle as it left the scene. JCPD detained suspects in the vicinity and a male non-student has been arrested. The fraternity has been placed on interim suspension pending a complete review of the matter.

#### **SAFETY TIPS and RESOURCES:**

\*Be an active bystander. When you observe conflict or unacceptable behavior, take steps to make a difference: assess the situation, evaluate options, and select a strategy for response. That could include reporting suspicious persons or behavior to Public Safety or the local police.

\*All ETSU recognized student organizations must register events with alcohol and follow the risk management policy and procedure outlined on the SORC website.

\*Be aware of your surroundings, points of egress, persons in the vicinity, and possible safe locations in which to hide if necessary.
